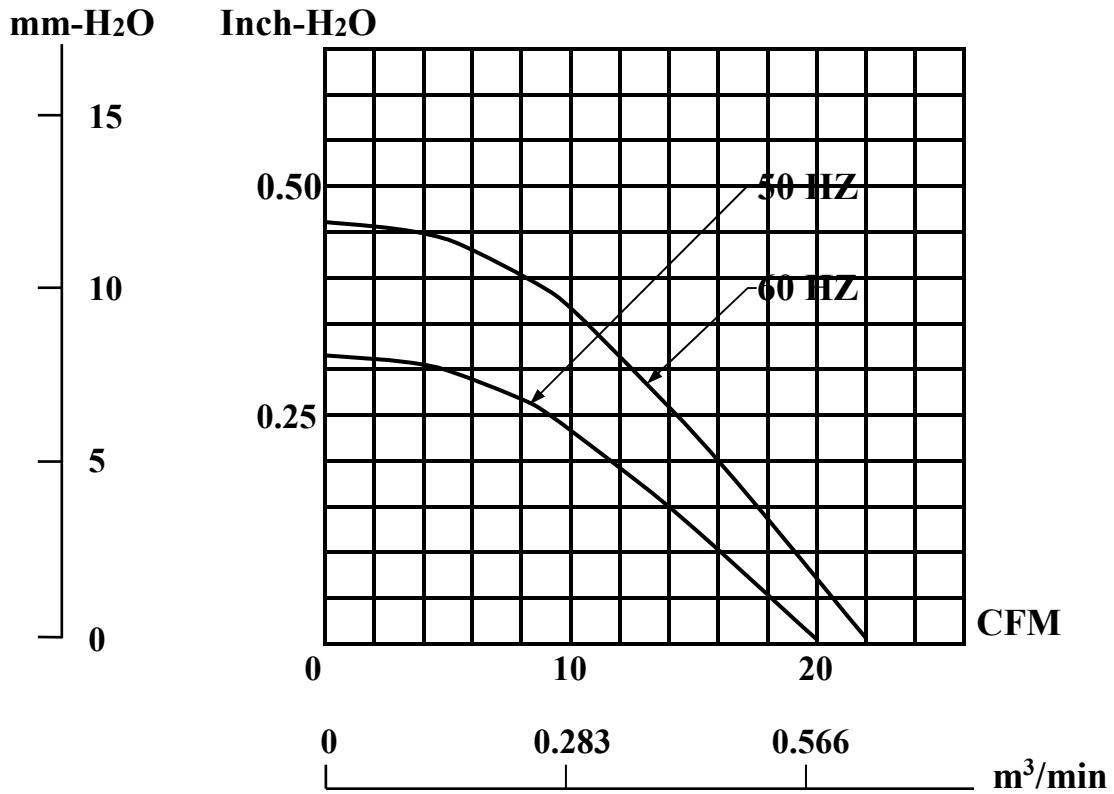

PRESSURE**

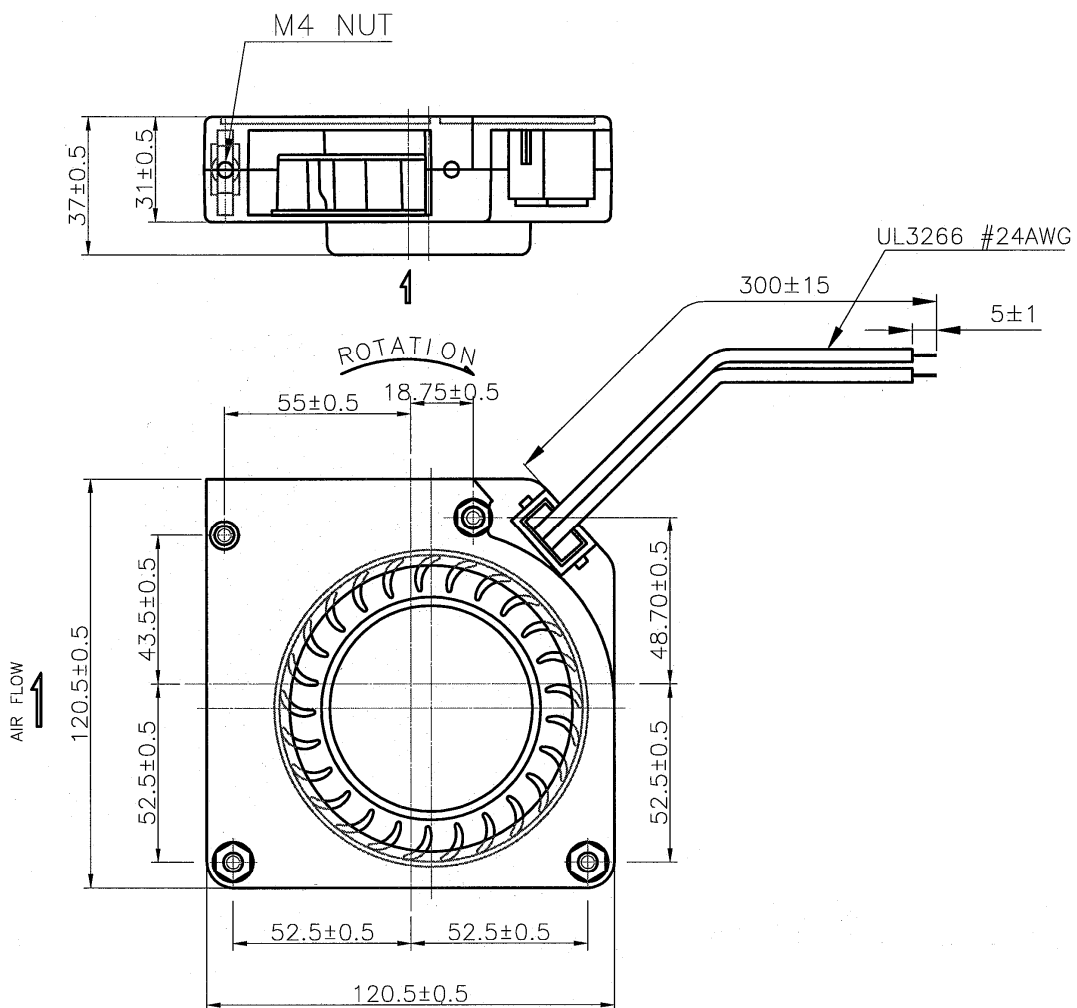
