


## REACH 符合性宣告 REACH COMPLIANCE STATEMENT

茲保證建準集團(含建準電機工業股份有限公司、昆山廣興電子有限公司、北海建準電子有限公司、北海立準電子有限公司及菲律賓建準電子有限公司)所有產品均符合歐盟 REACH 指令 (EC)No1907/2006。

本公司產品在正常使用狀況下並不會滲漏或釋放危害物質(包含附錄 X VII 限制清單及 251 項高度關注物質)，且無同時符合每年進口量超過 1 公噸以上及該物質在產品中使用濃度大於 0.1%(w/w)條件的物質(註)，依照 REACH 法規第七條之規定無需向歐盟化學管理署(ECHA)辦理成品中物質的註冊及申報。

本公司將持續關注歐盟 REACH 法規修訂訊息，當 ECHA 更新附錄 X VII 限制清單或高關注物質時，我們將再次執行產品的評估及檢查。如有衝擊到 SUNON 產品，SUNON 將立即通知客戶，並依據歐盟 REACH 法規所公佈之通報時程向 ECHA 進行申報。

SUNON (including Sunonwealth Electric Machine Industry Co., Ltd., Sunon Electronics (Kun Shan) Co., Ltd., Sunon Electronics (Beihai) Co., Ltd., Lizhun Electronics (Beihai) Co., Ltd. and Sunon Electronics Philippines Corporation, called SUNON below) guarantee that all the products made by SUNON comply with the rule of EU REACH Regulation (EC) No1907/2006.



Our products will not leak or release hazardous substances, including Appendix XVII and 251 items in substances of very high concern (SVHC), under normal use conditions. The products do not import more than one ton annually neither the concentration of the substance used in the product greater than 0.1% (w/w) (Note). According Article 7 of the REACH Regulation, we are not required to process registration and declaration of substances in article to the European Chemicals Agency (ECHA).

SUNON will continue to pay attention to revision information EU REACH Regulation. When ECHA updates the Appendix XVII restriction list or SVHC, we will perform product evaluation and inspection again. In case of impact on SUNON products, SUNON will immediately notify the customers and report to ECHA in accordance with the notification schedule announced by the EU REACH Regulation.

Note 1: The lead contented in homogeneous materials may be >0.1% (w/w), Such as steel alloys, copper alloys, high melting point solder, ceramics and glass, etc, but it does not meet the conditions of Article 7(2) of REACH, so it is not necessary to process registration and declaration of product substances to the European Chemicals Agency (ECHA).

Note 2: Specific plastic material PPE and parts of PCB laminates contain TPP(CAS No. 115-86-6), and the concentrations are exceed 0.1%.

Note 3: Specific tubing contains DBDPE (CAS No. 84852-53-9), and the concentrations are exceed 0.1%.
